

NEMBC 2023 Youth Media Conference Travel Subsidy Application Form

The NEMBC will be offering financial assistance to broadcasters travelling to Sydney from interstate or rural/regional areas for the purposes of the Youth Media conference. The Youth Media Conference will be on Friday 26 May 2023, in Sydney

This subsidy gives applicants travel support to cover costs (GST inclusive) of a budget return ticket.

Please note: this subsidy will cover 50 per cent to 80 per cent (GST inclusive) of a return budget air, train or bus fare to the Conference for the purpose of the Youth Media Conference. Exceptional cases will receive a 81 per cent to 100 per cent (GST inclusive) subsidy.

The amount covered will depend on how many applications are made and available funds.

This subsidy offer is limited.

To be considered, applicants must:

- Complete and submit the form before **4 May 2023**
- Live outside of Sydney i.e. from a regional/ rural area or interstate
- Broadcast a program on community radio or has done in the last year
- Notify your station manager before applying
- Agree to the Terms and Conditions outlined at the end of this document

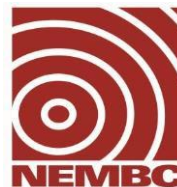
Applications for a travel subsidy close **4 May 2023**

Youth conference travel subsidies are allocated on a priority basis. This subsidy covers travel costs only at economy fares. The applicant is responsible for booking and paying for their own accommodation and asking their station to pay the small registration fee. Ask your station for assistance.

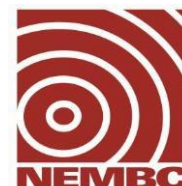

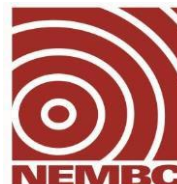

NEMBC Travel Subsidy Application Terms & Conditions 2019

1. The National Ethnic and Multicultural Broadcasters' Council from herein referred to as the NEMBC, are the producers of the NEMBC conference and providers of the 'assistance subsidy' as designated in this here agreement.
2. The term Applicant herein refers to the person(s) applying for the assistance subsidy.
3. The assistance subsidy is for the purposes of travel to the NEMBC annual Youth Media Conference.
4. The assistance subsidy is only provided for one low economy/ budget class return air, train or bus ticket or by private car at a rate of 10 km per 1 litre of regular petrol and/or fuel receipts, as calculated by the most direct route according to RACV travel map distances, from the Applicant's home or point of origin to the conference destination as determined by the NEMBC and back to the Applicant's point of origin or home.
5. Before applying for the assistance subsidy the Applicant must notify their radio station manager that they are applying for a travel subsidy from the NEMBC.
6. If the Applicant reserves a place for and does not attend the NEMBC Youth Media Conference, the Applicant's subsidy agreement may be revoked and/or any monies expended on the Applicant's behalf shall be fully reimbursed by the Applicant within seven (7) days to the NEMBC.
7. Applicants are solely responsible for booking and paying for their own economy/budget return air, train or bus ticket and present/forward to the NEMBC the original receipt as proof of purchase of such ticket(s) before lay claim to any reimbursement.
8. The Applicant shall be reimbursed at a predetermined percentage (inclusive of GST) of the price of the ticket purchased. The predetermined percentage will be agreed upon by the NEMBC and the Applicant prior to booking any travel arrangements.
9. Proof of travel shall be in the form of a tax invoice and/or receipt which the Applicant must provide to the NEMBC in order to receive their subsidy and free Conference registration. Failure to produce a tax invoice or alternative validated proof of purchase will render the subsidy agreement and free Conference registration null and void.
10. Reimbursement(s) shall be forwarded to the Applicant approximately two weeks after the final day of the Conference.
11. Hire car/ or Taxi costs shall not be covered by the NEMBC under any circumstances.
12. The Applicant is required to arrange and pay for their own accommodation.
13. If the Applicant is under the age of eighteen at the time of the Conference, authorisation for their attendance must be confirmed in writing duly signed and dated by a parent or guardian and forwarded to the NEMBC before assistance can be considered.
14. The NEMBC shall deem itself not to be responsible for any travel cancellation or failure of booked transit services either by the Applicant's personal action and/ or inaction, by any of the Applicant's representative(s) or Agent(s) working on behalf of the Applicant(s), industrial dispute(s), schedule alterations and/or technical difficulties, "force majeure", act of war, civil unrest, insurrection, act of terrorism either by armed insurgence, biological and/or chemical attack directly or indirectly, or any other issue(s) and event(s) that prevent the Applicant from attending the conference: No subsidy shall be reimbursed and/or paid out to the benefit of the Applicant.



15. The NEMBC reserve all rights to reject any application by any Applicant without entering into any dialogue or correspondence with the Applicant or any of the Applicant's agent(s) and/or representative(s).
16. If any provision of this agreement is or becomes invalid, illegal or unenforceable, the provision is deemed to be severed from this agreement but as far as possible all of the remaining provisions are not affected.
17. This Agreement constitutes the entire understanding of all parties and it cannot be altered or amended with unless agreed upon in writing by all parties here-in.
18. This Agreement shall be constructed in accordance with the laws applicable in the State of Victoria, all other States and Territories and the Commonwealth of Australia.
